Dear Messrs. Velazquez, King, and Smalls,

We are strongly concerned about an impending strike at Legal Services NYC, which will have devastating impacts on New Yorkers who desperately need your services. Your staff advocates for thousands of New Yorkers in housing and immigration court, and a strike would leave many without the essential support they need as they face serious legal challenges.

We understand that without competitive pay and with dangerously low staff retention at Legal Services NYC, quality legal services will be jeopardized for those who need it most.

We have concerns that Legal Services NYC is expanding its managerial positions that do not interact with your clients and do not render any legal service to them at the expense of staff positions, which are crucial to the work your organization does. We are troubled by LSNYC's prioritization of management salary increases and other internal spending over services for New Yorkers, with the highest-paid executive making nearly seven times the salary of your lowest-paid staff. We think funding should prioritize maintaining high-quality legal services for New Yorkers without compromising the quality of life of those providing the services.

The latest financial package does not reflect the current affordability crisis, neglecting the sustainability of the staff. Inadequate compensation offered to Legal Services NYC employees threatens to worsen already difficult staffing and retention issues.

We are closely monitoring this situation, and urge you to come to a good-faith agreement with the Union and its members to ensure services are restored and workers are fairly compensated.
